PLEASE READ THE FOLLOWING INSTRUCTIONS CAREFULLY BEFORE AUDITIONS

AUDITION SCHEDULE

There will be three one-hour sessions. They will be 5–6 PM, 6–7 PM and 7–8 PM.
Each one will follow the example format listed below:

- Group I Session 5:00PM – 5:45PM Fifteen three-minute vocal time slots
5:45PM – 6:00PM Fifteen minute Group I Dance Call

(If needed a fourth session will be added from 8–9 PM.)

1. Each student will sign up for a 3 minute vocal time slot.
2. Each student should come prepared with a vocal selection of any style. Accompaniment should be either iphone or piano. A pianist will be supplied if desired. There will be no microphone allowed for singers.
3. During the 3 minute vocal time slot each student will be given the opportunity to sing a portion of his/her selected vocal piece. No one can be assured of singing the entire song. Auditionees will be asked to perform some vocal exercises.
4. Each student should arrive at the Attaché Room at the beginning of his/her hour session to learn choreography. These steps will be taught to the auditionees.
5. The auditionees will perform the choreography with their group.
6. Each student should bring the Statement of Informational Concern, Personal Information Sheet with attached photograph (photograph will not be returned), and a prepared vocal selection to the audition. The auditionee should wear something that allows them to dance.
7. Students will be judged on their Vocal Presentation, Visual Presentation and Overall General Effect.
8. Students progress and attitude in the classroom will be checked.
9. Please remember that the decision that is made from this audition process is for one year only. All members of Attaché must re-audition every year. Obviously, more students will audition than there is room for in the group. Everyone should be respectful of all auditionees.
